This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non-hazardous ingredients are also possible.

### Section 6 - Accidental Release Measures

**Accidental release:** This product is sold in small packages, and the accidental release from one of these is not usually a cause for concern. ## Section 10 - Stability and Reactivity

**Reactivity:** This product is unlikely to react or decompose under normal storage conditions. However, if you have any doubts, contact the supplier for advice on shelf life properties.

Ecotoxicity: Highly toxic to fish LC<sub>50</sub> (96 hours) = 0.65 mg/L rainbow trout (*Oncorhynchus mykiss*). Highly toxic to aquatic invertebrates, EC<sub>50</sub> (48 hours) = 0.6 mg/L Water flea (*Daphnia magna*).
