CATEGORIES: Work may be submitted into the following categories:

- 1) Oil and Acrylic 2) Watercolor 3) Mixed Media, Fiber Arts, and Collage
- 4) Photography & Digital Art 5) Sculpture & 3-Dimensional Art
- 6) Colored Pencil, Graphite, Pen & Ink, Pastels, Printmaking

REGULATIONS:

1. All work must be appropriate for viewing by all ages.
2. All entrants must be at least 18 years of age.
3. All artwork must be the original work of the submitted artist. No copyrighted work will be accepted unless the submitting artist holds the copyright. No copies, giclee's, reproductions, or kits will be accepted.
4. The submitted work must have been completed in the last three years (2023 to present) and shall not have been entered into a TAL/NBAL Spring Show previously.
5. Work entered in a category MUST conform to the media of the category. Example: No mixed media elements in a watercolor entry, no drawing on a photography entry, etc.
6. Size for hanging pieces shall be **no larger than 52 inches in width or height.**
7. Any framed artwork larger than 16" x 20" that requires protection MUST use acrylic/Plexi in place of glass (except pastels). Any artwork not adhering to this rule will be rejected.
8. All hanging work must be framed, with the exception of stretched canvas work that is gallery-wrapped and has no exposed staples or unfinished edges. Unframed work painted on wood panels must have finished and/or painted edges. Photography printed on alternative substrates will be accepted with float, exhibit, or flush mount hanging system in lieu of traditional framing.
9. **All hanging work must be ready to hang with securely fastened D-rings or similar and braided picture wire that is not visible when hung. No saw tooth hangers or protruding screw eyes. Incorrect hanging hardware will be rejected.** All entries must remain on exhibit throughout the show. Artwork which is purchased during the show will be handled on an individual basis.
All artwork must be picked up between 3:00-4:00 pm on Sunday, April 12th.
10. Entry of your work into the show implies an agreement that NBAL may reproduce images of artwork for publicity and/or promotion of future art shows.

Purchase of Artwork: Purchases can be made by cash, check or charge. NBAL will collect 15% sales fee on all purchases. NBAL will collect the money for all purchases and remit a check to the artist, less the 15% fee. Checks for sales will be mailed to the artist within two weeks of end date of show. Purchased artwork will remain on display in the show until take-out on Sunday, April 12th.

NBAL will exercise reasonable care of entries and provide security during show hours. Neither NBAL, nor the Holiday Inn, will assume any liability for loss, theft, or damage. Titusville Art League dba NBAL is a non-profit 501(c)(3) organization, registered in the state of Florida ID#CH6002 to promote and encourage the arts in our local community.
