

He holds a master's degree in law as well as a journalism degree and has been a professional journalist for 14 years, winning the Illinois Higher Award for Public Service Investigative Journalism and Journalism from United Press International. In 1981, after two years of investigating evidence of Jesus, Lee received Christ as his Savior and then became a pastor at two of America's largest churches - Willow Creek Community Church, Chicago in 1987 and Saddleback Valley Community Church, California in 2000. In 2002, he left Saddleback to focus on writing. The author of the new york Times bestseller, author of nearly 20 books, he was described by the Washington Post as one of the most popular apologists of the evangelical community. His journey from atheism to faith has been documented in books, winning Gold Medals, The Case for Christ, Inside the Mind of the Nonchurches Harry and Mary, and The Case of Faith. His other bestsellers include Surviving The Spiritual Inconsistency in Marriage, which he co-wrote with his wife Leslie; The outrageous assertions of God and what would Jesus say? Lee also shared the prestigious ECPA Jordon Christian Book of the Year award in 2005 for his 2005 program, which he co-wrote with the film The Passion of Christ. Lee is also a co-author of a program teaching contagious Christians, which is used throughout And his articles have been published in various journals, including The Discipleship Journal, Marriage Marriage Christian Research Journal, guidebooks and solutions. He is also the editor and columnist of Outreach on-line magazine. Lee and Leslie have been married for 33 years and live in Southern California.
