# Sarah Feingold L'05



Sarah Feingold L'05 began taking silversmithing classes as a 12-yearold, and continued making jewelry at Skidmore College, where she majored in sociology and minored in studio arts and business. But in terms of making a living at her art, there were issues. She would create a piece and feel such an attachment, "I did not want to separate from it." That made selling difficult. Second, the delicate work done for long

hours was hard on her. "My fingers would bleed and my back would hurt," she says. Feingold came upon the idea of becoming a lawyer, and pursuing a career working with artists.

Six years out of law school, Feingold is the in-house counsel for Etsy, an online marketplace that provides artists and craftspeople a place to sell their work. The company, launched in 2005, now has seven million registered users and reported revenues of \$314 million in 2010. "It's an amazing company that changes people's lives.," Feingold says.

Connecting with the right people, and being able to ask for what she wants seems to be a theme in Feingold's professional life. When considering the College of Law, Feingold first reached out to Professor Barbara Walter in the School of Visual and Performing Arts. "I showed her my portfolio, I asked if I would be able to take independent study (at VPA) when I was in law school." Walter said yes and Feingold was able to continue her art on the side while she was studying law.

At the College of Law, Feingold studied intellectual property under Professor Laura Lape. "I said to her, I took all of your classes and I want to learn more from you," Feingold says. "She was a big supporter. She really helped me think outside the box." Through an independent study course with Lape, Feingold wrote an e-book, Copyright for Artists, in which she strived to make copyright law understandable to the layperson, "spelling it out, breaking it down to easy to digest pieces," she says.

After graduating, Feingold returned to her native Rochester, where she worked for the law firm of Lacy Katzen, making jewelry on the side. She discovered the Etsy website, and began selling jewelry on it. Feingold says she got to know every page of the website, and became familiar with the myriad of items created and sold by the artists. She also took note that the company did not seem to have a legal department.

In 2007, Feingold reached out to Etsy, first through a blind email to customer support. She introduced herself and said if the company ever offered a symposium for artists, she would love to speak at it. Rob Kalin, a founder of Etsy and then the CEO, got back in touch. Feingold told him more about her background and the e-book she had written. "I hung up the phone and said, 'I want to work for this company." Feingold realized she needed to meet with Kalin in person.

She then decided to go for it. Feingold booked a JetBlue ticket, wrote Kalin to announce she was arriving for a meeting, and flew from Rochester to New York. She was hired that day. Within a month, Feingold had sold her car and gotten a sublet. She was the 17th or 18th employee hired, and now the company employs about 200. "It's challenging to work for a creative start up," Feingold says. "It makes me happy that I am doing what I set out to do, which is to help artists. It's my dream job."
