# **Privacy Policy**

# iMT Co., Ltd.

# I. Purpose

iMT Co., Ltd. (hereinafter referred to as "the Company") has established this Privacy Policy (hereinafter referred to as "this Policy") to strengthen privacy and information protection, ensure the proper protection and management of personal data collected, processed, or used in the course of our business operations or entrusted services, and to comply with relevant laws and regulations in Taiwan to safeguard your rights and interests.

# **II. Scope of Application**

- 1. # **III. Policy Statement**

- 1. Collection, Processing, and Use of Personal Data
- The Company follows the principles below when collecting, processing, and using personal data:
- (1) Principle of Good Faith We collect, process, and use your personal data in a fair and honest manner, respecting your rights.
- (2) Principle of Minimization and Relevance We collect, process, and use personal data only within the necessary scope for legal compliance or business purposes, ensuring reasonable relevance to the stated purposes.
- (3) Principle of Transparency In accordance with Taiwan's Personal Data Protection Act, we clearly inform you of the relevant details regarding the collection, processing, and use of your personal data.
- (4) Data Integrity and Accuracy We maintain the integrity and accuracy of your personal data and update it when necessary.



#### 2. Disclosure or Provision of Personal Data to Third Parties

The Company does not disclose your personal data to any third party unless required by law or under the following circumstances:

- (1) When requested by judicial authorities or other competent agencies in accordance with legal and formal procedures.
- (2) When necessary for the promotion of public interest or to prevent serious harm to the rights of others.
- (3) When necessary to protect your life, body, freedom, or property.
- (4) With your prior consent.
- (5) When disclosure is beneficial to your rights and interests.

### 3. Personal Data Security Management

The Company establishes appropriate control measures in accordance with the Personal Data Protection Act, including but not limited to resource allocation, risk assessment, internal audits, and staff training to ensure effective implementation of privacy protection mechanisms.

#### 4. Log Records and Retention

The Company retains usage records, activity logs, and related evidence as part of its privacy and data protection management practices.

#### 5. Use of Cookies

The Company's website or applications use cookies to record and analyze user behavior to provide customized content and improve your experience. You may adjust your browser settings to control cookie acceptance; however, disabling cookies may limit certain website functions.
