Congratulations to the Winners!

Elections were held at the General Dinner Meeting, Tuesday, December 9, 2025. It was very well attended by 184 voting Members. In addition, 19 votes were cast during the daytime election period. 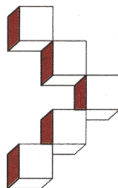
