



The Mark & Trina Ramsey Foundation does our best to ensure that we maintain compliance with the varying State Charity Registration Requirements & pay the required fees mandated by most states on an annual basis. Several states ALSO require specific disclosure statements related to solicitation, even if that solicitation is passive (via online donations via website or facebook posts). To that end, below we're displaying the required disclosure statements, by state. If your state isn't listed, this does not mean MTRF is not registered there, as most state-required information is already contained within MTRF's website content. Prior to making your donation, please review any applicable statements below:

COLORADO - "Colorado residents may obtain copies of registration and financial documents from the office of the Secretary of State, 303-894-2860, www.sos.state.co.us/ re: Reg.No #20173009672 ."

FLORIDA - "A copy of the official registration & financial information may be obtained by the division of consumer services by calling toll-free (800-435-7352) within the state of Florida. ILLINOIS: "Contracts and reports regarding Mark & Trina Ramsey Foundation are on file with the Illinois Attorney General."

MAINE: "It is a violation of this chapter for any person or entity to solicit contributions from a prospective donor without fully disclosing to the prospective donor, at the time of solicitation but prior to the request for contributions, the name and physical address of the charitable organization for which the solicitation is being conducted." MARYLAND: "For the cost of postage and copying, documents and information filed under the Maryland charitable organizations laws can be obtained from the Secretary of State, Charitable Division, State House, Annapolis, MD 21401, 800-825-4510." MICHIGAN: No disclosure statement required. However, the state Attorney General's office strongly encourages inclusion of the organization's Michigan registration number (MICS # CS57208) in all solicitations.

MINNESOTA: MTRF is located in Colleyville, TX and is a 501(c)(3) public charity; 100% of contributions are tax-deductible. All MTRF programs are clearly described at www.ramsey.foundation, including in the online donation center where donors are presented with details on each specific program prior to making donations.

MISSISSIPPI: "The official registration and financial information of Mark & Trina Ramsey Foundation may be obtained from the Mississippi Secretary of State's office by calling 1-888-236-6167. Registration by the Secretary of State does not imply endorsement by the Secretary of State." ([Miss. Code Ann. § 79-11-523\(3\)](#))

NORTH CAROLINA: "Financial information about this organization and a copy of its license are available from the State Solicitation Licensing Branch. The license is not an endorsement by the State." MTRF is based in Texas; upon request, the name and either the address or telephone number of a representative to whom inquiries could be addressed, the amount of the contribution which may be deducted as a charitable contribution under federal income tax laws &/or the source from which a written financial statement may be obtained shall be provided.

OHIO: The principal place of business of Mark & Trina Ramsey Foundation is Colleyville, TEXAS. MTRF is recognized as a 501(c)(3) public charity and uses donations to support health & wellness programs of those in need around the globe.
