Vendors: We don't do first-come, first-serve, as we try to balance with vendors to attract families and shopping traffic for our vendors. We are looking for a good mix of locally made products, artists, non-profits and local businesses. We do prioritize our local vendors. At this time, we are not accepting direct sellers as vendors.

WEATHER POLICY: 1st Friday is a Rain or Shine event. Participation is at the discretion of the individual. In the event of severe weather and the 1st Friday Committee determines that there is a threat to public safety the event may be modified or cancelled.

VENDOR FEE REFUND/TRANSFER POLICY: Vendor fees are non-refundable and cannot be transferred.

COST: Spaces are \$50/ea 1st Friday; \$250 for all six if paid in advance, in full. We will forward you an invoice once you are accepted as a First Friday vendor.
