A FEDERAL ELECTION CONTRIBUTION BY
CASH OR CHECK

1. The information requested by this form is collected to meet the reporting requirements of the Federal Election Campaign Act when a contribution by cash or check is made to the Fauquier County Democratic Committee to fund federal election activities.
2. This form must accompany any contribution made by cash or check to fund federal election activities.
3. If contributing cash please give your contribution and completed form to a Committee officer or authorized agent of the Committee as soon as possible but not later than ten days after the Date of Contribution on the form.
4. If contributing by check please mail your check and completed form to the **Fauquier County Democratic Committee, PO Box 213, Warrenton, Virginia, 20188-0213.** Your check and form may also be given to a Committee officer or authorized agent of the Committee. The contribution should be in the hands of a Committee officer or authorized agent of the Committee as soon as possible but not later than ten days after the Date of Contribution on the form.
5. Incomplete or inaccurate information may delay the use of your contribution or require your contribution to be returned.
