The Tazewell County Sheriff's Office is the county's main law enforcement agency. Sheriff's Office responds to FOIA requests within 5 working days of filing. The first 50 copies of black and white regular paper copies are provided free of charge. Extra copies cost 15 cents each. Each copy of accident reports costing \$5 the fee for an accident reconstruction report is \$20. Sex offenders living in the state of Illinois are authorized to register. The clerk's office is open from 8:30 a.m. to 5:00 a.m. Monday to Friday. Copies of the files of the pre-1989 cases are available in the Microfilm department in room 204(s) of the court. Regular copies of case records are \$2 for the first page, 50 cents per page for the next 19 pages and 25 cents for each subsequent page after 20 pages. Certified copies cost \$6 per document. Apply a check or money order to process the processing fee in the processing request. For live requests, vital records office is open Monday to Friday from 10:00 from .m to 15:00.m. Please note that only credit card payments are accepted to receive a fax. In addition to copying fees, Vital Records also charges \$12.95 for the handle plus a \$19.50 UPS fee. Tazewell County marriage records are kept and provided by the county clerk's office, while the Vital Archives department of IDPH provides only a copy to verify the marriage. To request marriage confirmation, use the Marriage/Civil Union Register Verification Application Form and follow the filing procedure described above for divorce records. The fees and requirements for requiring a divorce check are the same for checking the marriage file. The data on the death and birth of Tazewell County is led by IDPH. The above requirements shall also apply at the request of certified copies of the birth or death certificate by the Office of Circulation Records. Each certified copy of a birth record costs \$10 (\$15 for a long-format birth record) and \$2 for each additional copy. The fee for the first certified copy of the death record is \$19 (\$10 for an uncertified copy), while each additional copy of the record requested along with the \$4 cost. To request a copy, download and fill in the form for recording your birth or death certificate. Submission of the application following the procedures referred to above for applying for divorce verification. Cash payments are accepted for personal requests, while requests to send by post must be by cheque or by money or cheque of the hotel. Only credit/debit cards are accepted for online requests.
