## Pine Township Ordinance Review

Chapter 3 - General Provisions

Section 3.11 - Fences

Gorby moved, supported by Krause to add after the last sentence of letter A "All fences, regardless of construction materials, must be reasonably aesthetic for the location."

Chapter 16 Special Land Use

Section 16.02 - Application and Review Procedures

Section 16.02 B – Gorby moved, supported by Buchholz, to add "to the Zoning Administrator" between the word "submitted" and the words "at least thirty (30) days".

Section 16.02 D – Gorby moved, supported by Christensen, to add the word "relevant" to the last sentence, so that the sentence reads "including recommendations or reports from the Township planner, engineer, or other relevant party".

Section 16.02 E - Gorby moved, supported by Andresen, to add to the first sentence the word "owners" and to change the word "located" to "reside" so that the sentence reads "regardless of whether the noticed property owners or occupants reside in the Township."

Section 16.02 F – Gorby moved, supported by Buchholz, to insert the word "public" between the words "the record" in the last sentence so that the sentence reads "incorporated into the public record." MOTION PASSED

Section 16.04 - Special Land Use Specific Requirements

Buccholz moved, supported by Gorby, to change the word "Sales" under MM in the introduction to the word "Businesses" so that MM in the introduction matches MM "Wholesale Businesses" in the main portion of Section 16.04.
