## Fictitious business name san bernardino ca

Some countries require fbn to be submitted to the Office of the Secretary of State. Normally, you must submit an FBN if the name under which you do business is anything other than your own name if the company is the individual owner. If the company is a partnership or is established but is known to the public by business name, you need FBN. For example, a specialty restaurant chain that uses different names for individual locations is required to FBN for each name.
