


### Plant 4.0 STARTUP INCUBATOR – Focus on the process

To apply, you have to record a short video of around 1min and fulfil an application form. Corporate members of Plant 4.0 will then select the startups they want to see during the step 2 – The Pitch (more details on the video and the form in slides after)



#### **STEP 2 – PITCH**

Pitch your company and your technological solution to a panel of experts

#### STEP 3 – JOIN

Join the Plant 4.0 network as a startup and collaborate with the Plant 4.0's industrial partners

How does the pitch session unfold ?	<ul> <li>Each company will have 7 minutes to present its business, technological solution, and desire to join the Plant 4.0 startup accelerator, followed by 3 minutes to address questions from the audience.</li> </ul>
Who is the pitch session intented for ?	• The jury members consist of the innovation and technical teams from various partners. Thus, the emphasis should be on a technological collaborative approach (co-development) rather than a pure commercial presentation. Corporate partners need to understand your solution and how they could deploy it in their facilities.
