make use of volunteers who will help us sharing our story and spreading the word. The Foundation's financial resources consist of:

Remuneration policy

The directors receive no remuneration for the duties they perform. However, the directors may receive reimbursement of the costs incurred by them and a nominal attendance fee. We do not have any staff at the Foundation and hence do not pay any salaries. As also stated in our Financial Year Report in detail, all our board members sponsor children from the 22STARS Foundation themselves, help actively with fundraising and visited the projects in Uganda on their own cost. So far only the Executive Chairman S.R. Airoldi has received a "not excessive attendance fee" ("Niet bovenmatig Vacatiegeld). As she is the one who has a lot of work with preparing the meetings and the aftermath of it. Additionally S.R. Airoldi is doing all email communications with the sponsors and donors on a voluntarily base. By times the Foundation hires Stella a freelancer for things such as website building, social media and program coordination in Uganda. This is because she is willing to do it way cheaper than when we would have needed to hire someone else.



The 22STARS FOUNDATION runs all their programs in the Acholi Quarter area in Kampala and the Danida area in Jinja, Uganda. Our programs include the whole community living in these areas, thus excluding no-one, as we believe that empowerment lies in helping a community as a whole and not discriminating anyone. Our first program was finding long-term sponsors for children living in poverty in these areas. At the beginning of 2018 we started sending more than 250 children to school ranging from pre-school to boarding school now this number is 440. Our second program is our nutrition program, since October 2016 we are serving weekly a hot mea with meat to the kids and give food supplies to malnourished families. Our third program is our Entrepreneurship Program, in which we give the care-takers and parents of our sponsored children Small business trainings and micro credit loans. Our fourth program is our Health program. Under this program we carry out various activities based on the needs of our beneficiaries, such as handing out mosquito nets, beds, matrasses, clothes, water filters and medical treatment. Within our Health Program we run a sub project for Eye-Health care. Our fifth program is our Computer Literacy program, which we started in 2020. Each day after school the children can come to our office to use the computers and we have a computer teacher educating them. Our sixth program is our Music program, which we started in 2021. We bought music instruments and hired 3 music teachers, who teach the children daily certain music instruments. Our seventh program is our Local Leadership program, which we

Income means the donations received in the year under review. We basically divide our Income in two types of Income. The first one is from General Donations which are received through our campaigns on Donorbox, through our bank account and PayPal account. Most of the time these donations are made one time and even when they are recurring, they could be stopped anytime. The second one is from Sponsors, who usually make long-term donations for the support of their sponsored child to enable him or her to go to school. Payments for this have been made through PayPal, Donorbox and direct bank transfer. These sponsorships are recurring and whenever a sponsor drops out, we put the child back on our website and try to find as soon as possible a new sponsor. For the ANBI Standard Requirement Form we also highlighted the following categories: income from grants and income from donations. Additionally, we split the income over donations made by private people, by charities and by businesses. We basically divide our costs over our two income streams: general donations from donors and sponsorship donations from our sponsors. Our costs were made towards our programs in Uganda. These were the following programs: Education (Sponsorship) Program, Nutrition Program, Computer Program, Small Business Program, Music Program, Health Program and Local Leadership Program.
