However, in light of the trial court's ruling, the State's theory that Appellant failed to communicate that he was acting under a strong provocation is irrelevant. {¶19} Even if the trial court had considered the alternative theory of the case, the State did not provide sufficient evidence to prove beyond a reasonable doubt that Appellant acted with a state of mind indicating that he had a reasonable excuse or justification under R.C. 2903.02(D)(1). {¶20} At trial, the State presented the victim's statement to the police regarding the events surrounding the stabbing as evidence of Appellant's guilt. At trial, the victim's version of events was consistent with his statement to the police.
