The Bitch Qwner will pay the Stud Owner(s) the sum of prior to stud service, which took place/will take place on the following date(s) OR if first pick of the litter is agreed upon, Stud Qwner has three (3) weeks to make his/her pick before all others, regardless of bitch owner's waiting list, reservation list, and/or deposits received. The Stud Owner(s) has taken every care with the welfare of the stud dog. The Stud Owner confirms that to the best of his/her knowledge the stud dog is both fertile and in good health. The Stud Owner gives no warranties regarding the birth of any puppies arising from the mating(s) covered by this contract. Bitch must be at least two (2) years of age by time of breeding. Bitch Owner must notify Stud Owner within 72 hours of when whelping ocured. Bitch Owner must notify Stud Owner in writing, no later than 70 days after breeding, if no pregnancy results from the mating. Failure to do so will result in no return service being provided, no monetary refund will be given. If bitch ownership changes, this contract is null and void. A litter, for the purposes of this contract, is defined as one (1) live puppy. If breeding does not take, a repeat breeding will be given to the same bitch on her next season, no monetary refund will be given. If the bitch fails to conceive on the return service, this contract is terminated. If other arrangements have not been made with the Stud Owner(s) and the bitch is not bred on her next season, or is bred to another stud dog on her next season, the amount paid is forfeited and the contract is null and void. BITCH OWNER AGREES TO:

- 1) Pay the agreed Stud Service Fee before the bitch is serviced
2) Provide documentation of a current (within 6 months of breeding) clear Brucellosis screening

- 3) Send the bitch in good health, free of parasites (must be on a flea and tick preventative) or infections, and in season, and provide documentation of up-to-date vaccinations (dhpp, bordatella, and rabies)
- 4) Keep the bitch properly confined following breeding to ensure no other dog could mate her accidentally before her season is complete
- 5) Agrees to not knowingly sell or transfer puppies whelped as a result of this breeding to any person or firm connected with the business of resale or wholesale of dogs.
- 6) Pay any and all veterinary and financial arrangements, including, but not limited to traveling expenses, emergency vet care related to this breeding, etc.
- 7) Bitch Owner is responsible for all testing done to the bitch prior to and during breeding to assure the proper timing of said breeding.

- 8) Provide food for the duration of bitch's lodging at stud owner's home
- 9) To pay \$10 per day, if bitch is with stud owner more than 5 days **INITIALS:** _____

STUD DOG OWNER AGREES TO:

- 1) Provide a copy of stud dog's pedigree, if requested
- 2) Provide copies of any genetic and/or OFA tests and results of the stud dog, if requested
- 3) Provide documentation of a current clear Brucellosis screening, if requested
- 4) Take proper care of the bitch while in stud owner's charge, keeping bitch inside, and away from all male dogs except the stud dog
- 5) Sign litter registration promptly upon payment of stud fee
- 6) Will breed bitch with stud dog 2-3 times naturally; more if given time **INITIALS:** _____

OTHER CONDITIONS:

In breeding animals, there is always a risk that one may be injured during the process. 1. Bitch Owner agrees to hold the stud dog or his/her Owner harmless from any liability or damage. In addition, the Bitch Owner understands that the Stud Owner accepts no liability for the actions of this bitch while in their care, including but not limited to personal injury or property damage. 2. If for some reason the bitch dies while in the care of the Stud Owner there will be **no** fees owed to the Bitch Owner until a necropsy is performed by an accredited veterinarian and a finding of negligence is made, or the veterinarian finds a reason to believe physical harm was done to the bitch. If the veterinarian can attribute the death of the bitch to the Stud Owner, a fee equivalent of the stud fee will be paid to the Bitch Owner by the Stud Owner. **INITIALS:** _____
