Reinsurance Finance Manager

The successful candidate will also prepare summaries of the underwriting performance and present them to management.

Key duties & responsibilities:

- Reviewing reinsurance bordereau reporting for accuracy and consistency with contractual terms, including premium, claim, and commission activity
- Recording reinsurance technical accounts to the ledger and performing account reconciliations to reinsurance bordereau activity
- · Analyzing financial data to identify trends, variances, and opportunities for improvement
- · Working closely with underwriting to ensure accurate financial reporting
- Assisting with internal and external audits by providing necessary documentation and explanations
- · Preparing and presenting underwriting reports to management and stakeholders
- Liaise with Treasury function to ensure premiums are received and claims are settled in a timely fashion and in accordance with contract terms

- Qualified Accountant (CA, CPA, ACCA) with at least 5 years of experience working within insurance/reinsurance, with at least 3 years in a similar role
- · CPCU, ACII or ARe designation is required
- Experience with financial reporting, regulatory compliance, and reinsurance contracts is an advantage
- An understanding of relevant Bermuda regulatory requirements and standards in addition to Generally Accepted Accounting Principles (GAAP/IFRS), is necessary
