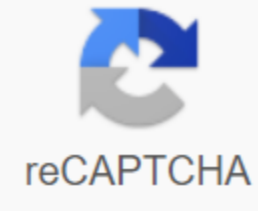

For information about sex offenders, please visit the following links: Registered Sex OffendersInfo Registration Of Abused Matters, which cannot be answered from the links that are provided, may be referred to the Sex Offenders Registrar at 240-313-2169 Megan Kanka Registered Sex Offenders appointed by a risk judge after a court hearing: Level 1 (low risk of reoffending); Level 2 (average risk of reoffending) and level 3 (high risk of reoffending). By law, only Level 2 and Level 3 sex offenders are included in this online directory. The Sex Offender Registry contains various information about registered sex offenders, including, but not limited to: multiple photos, names (pseudonyms), home and/or work addresses, as well as convictions that require registration, if applicable. Level 1 and Level 2 offenders are required to submit updated photographs every three years; Level 3 offenders must submit updated photos annually. Level 3 offenders and criminals designated as sexual predators must personally check their address every 90 days at the police department in which they live. If the offender's appearance has changed, the police can take a picture of the offender and submit an updated photo to the registry. Get information about Level 1 offenders and offenders whose level of risk has not yet been determined by the judge by phone at 800-262-3257, 8:00 and 4:30 p.m. Monday to Friday (excluding holidays). Callers must have the person's name and one of the following - exact address, date of birth, driver's license number, or Social Security number to find out if that person is on the registry. The Dru Sjodin National Sex Offender Public Website (NSOPW), coordinated by the U.S. Department of Justice, is a collaborative effort between government agencies hosting public sex offender registries and the federal government. This website is a search tool that allows the user to send a single national request to obtain information about sex offenders using a number of search options. The search criteria are limited to what each individual state can provide. In addition, because the information is posted in each state, not by the federal government, the search results must be verified by the user in the state where the information is posted. Users are encouraged to visit relevant government websites for more information and/or recommendations if necessary. Once inside the database accept the user agreement, fill in the criteria and start by state, city or postcode. When the names appear, click on the name and photo, address and type of crime will appear. Employee Package to enter the back to the beginning of the search for offenders Registered Sex Offender Information Registered Sex Offender Information Sheet Requirements Frequently asked questions (Registration and Restrictions) What is a registered sex offender? Sex offenders are minors or adults who have committed a Class A, Class B, Class B, Class C or some gross misdemeanor and are required to register for life, fifteen years and ten years respectively. Registration laws are covered by RCW 9A.44.130. To determine a conviction for sexual offences requiring registration, see RCW 9A.44.128. What do the levels mean? The levels of sex offenders are determined by several factors related to the offender and the nature of his or her crime in order to identify possible risks to society as a whole. Adult and juvenile offenders are assigned a risk classification for the purpose of notifying communities by law enforcement. Offenders are classified as Level I offenders if their risk assessment and other factors indicate that they have a low risk of sexual offence in society as a whole. Level I offenders are not published on the state sex offenders' register in Washington. However, out of compliance and transitional level I offenders are published. For specific information at Level I, contact your local law enforcement. Offenders are classified as Level II offenders if their risk assessment and other factors indicate that they have a moderate risk of sexual crime in society as a whole. Grade II offenders are published in the state registry of sex offenders in Washington. Offenders are classified as Offenders III if their risk assessment and other factors indicate that they are at high risk of sexual crime in society as a whole. Grade III offenders are published in the State Register of Sex Offenders in Washington. Do offenders have restrictions on where they can live? This depends on whether the offender is under the supervision of the Department of Corrections, Juvenile Rehabilitation or The District's probationary period. If it is supervised and has certain restrictions or restrictions imposed on them by the Department of Corrections or the sentencing court upon their release. These may include restrictions on living, not being near children, having a curfew, or not drinking alcohol or taking drugs. If they are found to be violating their restrictions, they may be sent back to prison or to prison. Offenders who have completed their time under supervision can live where they choose without restrictions. You can contact your local DOC office to find out if the person is under surveillance. RCW 9.94A.8554 covers public protection zones. In 2014, the Sexual Offenders Policy Council conducted a study of the policy on the release and accommodation of sex offenders who I know are sex offenders, why are they not on the website? For RCW 4.24.550, Washington State publishes only Level II, III and Incompatible or Transitional Level I offenders. If you are looking for information about a specific offender that is not published on the website, you can contact your local sheriff's office. They can provide you with information about specific Level I offenders. Call local law enforcement or the sheriff's office and report it. It is best to let law enforcement handle the situation rather than take it into their own hands. You can send information about specific offenders directly to law enforcement by clicking the button to provide tips or corrections for that offender in the state registry of sex offenders in Washington. How is a sex offender registered? Where is the sex offender registered? How and when sex offender registers are covered (RCW, 9A.44.130) and (RCW 9A.44.140). Offenders must register in person with the sheriff's office in their county residence. How do I report a convicted sex offender on Facebook? Follow Facebook's reporting guidelines. Frequently asked questions (community notification) Why did I receive a sexual assault notice? The Communities Protection Act 1990 (RCW 9A.44.130) requires a sex offender to register in the community where they live. Communities are notified that a level II or Grade III sex offender registers a new address. The Act is designed to inform the public about a particular offender, convict the offender (s), and share resources to help keep communities safe. Why didn't I get a sexual assault notice? Not every city or community races mail notice flyers or you can't live in notifications to a particular offender. Each jurisdiction of law enforcement determines how they notify the community. Some cities post information on their websites while others deliver flyers or postcards. Call your local police department or sheriff's office for more information. You can also for e-mail alerts for offenders who move within 1 mile of the address you choose. These emails are sent as soon as the system has been updated. Will I be notified when the sex offender is moving? No. The law requires communities to be notified that sex offenders move into the community, not when they leave. Why didn't I know about this before? Leaflets are distributed after a person is registered as a sex offender, and after the jurisdiction of the law enforcement agencies in which they register requests, receive and review all initial information about the offender's offence. This can take anywhere from two weeks to several months. Once all the necessary information is considered, the jurisdiction of law enforcement agencies may or may not change the level of the sex offender. This review should be complete and personally verified that the offender actually resides at his or her registered address before the community is notified. Can I copy and distribute the notification? If the community believes that the notice was insufficient, members of the community should contact local law enforcement or the sheriff's office to discuss the matter. If you think other members of the community should receive a notification leaflet, you can copy and distribute the notification (within reason). Are there things I can't do? Experts believe that sex offenders are less likely to be offended again if they live and work in an environment free of harassment. any action taken against the person named in the notice, including vandalism of property, verbal or written threats of harm; or physical violence against that person, his family or the employer may result in the arrest and prosecution of criminal acts. This information cannot be used in any way to threaten, intimidate or harass registered offenders. I'm not happy with this notification! People react differently to being notified of sexual assault. It is normal to feel upset, angry and worrying about a sexual offender living in your community. The Act was created to inform the public about when a level 2 or level 3 sex offender is moving into a community and to provide that community with education and resources. Will there be a community notification collection? Community notification meetings are at the discretion of local law enforcement agencies. If you would like to request a meeting or for more information about meetings, please contact your local sheriff's office or the police department. Should I attend a community notification meeting? community notification provides an opportunity to educate the community about sex offenders in general. Protecting children and adults in the community is a much more important task than simply knowing the whereabouts of registered sex offenders. Participation in the meeting also provides an opportunity to connect with other members of your community. This could lead to further conversations and future planning Protection. Who can I expect to see at the meeting? Local or county law enforcement officers; local probation units, Department of Corrections (MLC) and/or the Juvenile Rehabilitation Authority (MSA) if the offender is under supervision; Representative of the Community Victim Protection Agency; and possibly members of the local school district. Will the perpetrator be in the meeting? Offenders are strongly discouraged from attending the meeting on community notice. In rare cases, a sex offender may be present but not on the agenda of the meeting. Sometimes there are family members and friends of the offender or victim. Where can I find more information about Washington's sexually violent Predator (SVP) laws? How can I talk to my children about a sex offender notice? Talk to the children calmly about the person named on the notice leaflet. Open communication with children is the number one security tool for parents. Find out what community protection programs your neighborhood has by calling your local police department or sheriff's office. You can participate in or start neighborhood Block Watch, Citizens on Patrol, or other neighborhood security programs.
