How to Look If you type more than one word, the default database will look for entries that contain all those words. Example: If you are you for the Auschwitz memoir, you will find all the records with the conditions of Auschwitz and the memoir. To expand the search, try to find Auschwitz or a memoir to find all the records with the terms Auschwitz or memoirs. Boolean operators allow you to combine several search criteria: And narrows the search, because the record must meet all search criteria or expands the search, because the entries must meet either one or the other criterion and does not narrow the search because it finds entries that meet the first criteria, but excludes any that have a second criterion. Use an exclamation point (!) to search for wildcards: Example: Search Mem! find records with conditions memorial places, memorials and memory. Extended search allows you to clarify the results by language, date, location and more. We use a controlled vocabulary for our keywords. Enter the first five letters of the word to get a list of proposed terms from our library Thesaurus. You don't need to log in to search the Catalog. If you're a registered reader, you can log in to reserve material or you want to save the search. Until further notice, the details must be applied in person to the reading room.
