K-12 TUITION INVESTMENT FEE

K through Grade 3

7,814 Per Student Annually

4th through 8th grade

7,233 Per Student Annually

9th through 12th grade

Payment Plans (K-12 Only)

Paid in full

- Due August 1, or the first day your child is enrolled (receive a 4% discount)

50/50 Plan

- 50% + – Due August 1 (50% Tuition, All Book Fees, Activity & Supply Fees)
- 50% – Due January 1 (Balance of Account)

10 Payment Plan – Due on the first of each month – August 1 through May 1
LTCA sends the bill on the **first day** of each month, starting in August.

- Payment is **due** by the **10th day** of the month.
- A **\$25 late fee** will be charged for payments received after the **10th day of the month**.
- **Payments returned** because of **insufficient funds** will assess a **\$35 service charge**.

Overdue Payments

Quarterly and final grades will be withheld until all payments are current. Student Transcripts/Records will be released only after the account has been paid in full.

\$375.00 9th – 12th Grades (this includes yearbook)

\$325.00 5th – 8th Grades (this includes yearbook)

\$275.00 K5 – 4th Grades (this includes yearbook)

Activity Fee

\$300.00 4th-12th Grades Sports, Stanford Testing, lab access, Fine Arts etc.

Other Fees

\$ 25.00 Application Fee (per family, non-refundable)

\$100.00 Graduation Fee (12th Grade)

\$ 50.00 Graduation Fee (K-5)

\$ 50.00 Family Pay Early Registration (Before April 30th per child, non-refundable)

\$200.00 Registration Fee (After April 30 per child, non-refundable)

\$250.00 Marine Biology Class Fee. 11th and 12 grades only. (Non-Refundable only for students enrolled in the class)

Note: Discounted tuition may be available for active LTMC members and for households with multiple children enrolled in LTCA. These discounts are based on family need and determined on a case-by-case basis. Please contact the school's financial office for more details.

Financial Aid (K-12 Only)

A limited amount of Financial Aid is available. This assistance is based on financial need. The application process includes completing a confidential financial statement, which is filed electronically or mailed by the family directly to LTCA. Families requesting financial aid should refer to the school website for information.

Living Truth Ministry Church Tithing Discount

LTCA is a ministry of Living Truth Ministry Churches Int'l Inc. As you honor the Lord, we offer a 10% discount for Students K-12 whose parents are active tithing members for at least 6 months. The tithing discount may be applied to the tuition responsibility of the parent, after any scholarships or other discounts are applied. In the case of a family with multiple children, only the full tuition child is eligible for the Tithing Discount.

SUBSTANTIAL SCHOLARSHIPS

Step Up For Students is an initiative of the Florida Tax Credit Scholarship Program that provides K-12 education scholarships for low-income students. See attached flyer for more information. stepupforstudents.org

McKay Scholarship is for students with disabilities or special needs. McKay seats are currently Closed to any new applicants for the 2022-23 school year. We are currently at capacity for students with special needs due to limited resources. floridaschoolchoice.org/information/mckay

Family Empowerment Scholarship (formerly The Gardiner Scholarship Program) provides eligible students a scholarship that can be used to purchase approved services or products in order to design a customized educational program for the student. Scholarships can be used for specialized services such as speech or occupational therapy, instructional materials, tuition at an eligible private school, contributions to a college prepaid account and more. FACTS - All families are required to enroll in FACTS. To set up your account go to factsmgt.com and then "Parent Login." You may choose your monthly payment due date of the 1st, 5th, or the 10th of the month. Payments received after your due date will be accessed a \$25.00 late fee.

Financial Aid – Again a limited amount of Financial Aid is available. This assistance is based on financial need. The application process includes completing a confidential financial statement, which is filed electronically or mailed by the family directly to FACTS. This third-party service informs the school of the amount of assistance for which the family qualifies. The level of assistance is based on the Financial Aid for School Tuition

recommendation and the total amount of resources available. Contact the office for more information.

Multi-Student Discount

A multi-child discount is available to families with more than one child who attend LTCA Kindergarten through Twelfth Grades. The first child will pay full tuition, with the second child receiving a 15% discount. The third child and each additional child will receive a 25% discount. The amount of the discount may vary depending upon the amount of any scholarship that is awarded to the student.

In no case will the sum of a student's scholarship, plus any discount received, exceed the sum of a student's annual tuition plus any includable fees.

Includable fees are fees that are allowed to be paid by the scholarship funds, as defined by the scholarship directive. Any LTCA preschool sibling will receive a 10% discount off their lowest weekly rate.
