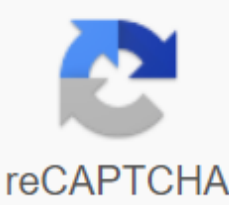

When answering a call, you must first hear an announcement from an automatic action, such as You receive a call from [prisoner's name], the prisoner under [object name]. Tap one (1) to accept. If the prisoner does not have caller funds and calls for the first time, the call will be free for a short period of time (often less than a minute). This is to enable the prisoner to inform you of where he or she is and to explain how calls from that facility work. After this brief conversation, the prisoner will be paused and will be presented with the opportunity: Pay (using a credit card) to continue the current call deposit funds for the prisoner to continue the call, and if there is no money remaining, the prisoner can use the funds for future calls to any number. Deposit funds into your own phone number to continue the call, and if you have money left, the prisoner can use the funds to call your number in the future, but the funds will not be available to call other numbers. You can also deposit funds: Make deposits via the Web, from telmate's website in pay.telmate.com. Make a deposit over the phone by calling telmate toll-free at 1-866-516-0115. Telemate's U.S. bilingual customer service representatives are available 24/7. Make cash or credit card deposits at telmate's deposit kiosk. A Telmate kiosk is located in the lobby. Voicemail To leave voicemail for a prisoner, friends and family can now leave a voicemail message to prisoners for up to 3 minutes for about \$1.25 (may vary slightly). Just call 1-866-516-0115 and follow the instructions. Block future calls If you don't want to receive calls from inmates, you can call 1-866-516-0115 (from the phone connected to the number you want to block). A live operator will help prevent prisoners from being able to call this number in the future. The prison has implemented tablets into each dorm. The tablets are supplied by telemate. Prisoners can now send and receive messages and photos from Contacts. Prisoners have access to music, videos, books and online training resources. If you have any questions or assistance with setting up an account or depositing funds, you can call 1-866-516-0115 or visit The administration, while proactive, has developed several new programs such as drug treatment, anger management programs, GED and religious services are available to prisoners. Umatilla County Correctional Facility has partnered with field schools to create two different types of trips for high school students. One is the Youth Assistance Program, which allows teenagers with underage possession (MIP) beliefs to come and talk to alcohol and drug classes. The second is the Leadership Program, which includes trips for teenagers with future professional interests. It is also the Umatilla County Sheriff's policy that there must be clear standards and procedures for processing prison mail that ensure the safety and security of the facility and the protection of inmates. The Umatilla County Correctional Facility encourages productive relationships between families and inmates and sees visiting inmates as a positive way to strengthen ties and increase the likelihood of success after release. The tour is an integral part of facility management, prisoner rehabilitation and community safety. The visit can improve public safety, encourage family relationships and reduce the risk of future criminal behaviour. In October 2018, the prison hosted a team of certified prison inspectors from across the state. The result was the highest score in the history of the facility, 99.3 percent compliance. Inspectors, certified by the Oregon Jail Command Council, routinely check participating Oregon prisons once every two years for compliance with Oregon prison standards. Inspectors inspect prisons using standards developed by the Oregon State Sheriff's Association that exceed state and federal government standards. The Umatilla County Jail has been and has been OJS compliant since 2005. We are very proud to demonstrate voluntary compliance with oregon prison standards. Umatilla County Court, Pendleton and Stafford The center in Hermiston are the homes of the state district courts, the Board of The Commissioner's Office, the District Prosecutor's Office, and many other important county departments. Every day, in addition to the numerous county and state employees who work in these places, many of our citizens also visit these buildings to conduct their business. The Sheriff's Office, through the Security and Transportation Unit (CSTU), works to ensure the safety, safety, and security of everyone in the Umatilla County court system. If you were in court, you probably noticed that there are uniformed deputies in the building all the time. They work every day to maintain order in the courtrooms and protect judges, their employees, jury members and all participants in proceedings. This often means capturing and removing persons or objects that may pose a threat to the peace, order and integrity of the court. The security and judicial transport programme is also responsible for the safe movement of defendants between the prison and the courthouse when necessary for court appearances. There are seven Umatilla County courtrooms (in two different cities) and the county jail can accommodate more than 250 inmates at any given time. Some of these prisoners are waiting to appear in court, while others are serving local prison sentences. There needs to be tremendous coordination between court staff, court security staff and regular prison staff to transport so many defendants from prison in a timely manner to the right places for trial. Ensuring that these functions work efficiently and safely is the responsibility of the Sheriff's CSTU. The unit is also responsible for transporting inmates to and from Oregon State Hospital and for other medical services not offered in the prison. They also transfer prisoners to and from other prisons and detention centres. The next time you visit the Umatilla County Courthouse(s), look around for our deputies. You can relax knowing that the Court's Security and Transport Unit is working hard to protect the integrity of the courts and ensure a safe visit. It is provided by the Oregon Department of Corrections and the Oregon Department of Justice in collaboration with the Oregon Sheriffs' Association and the Oregon Youth Authority. You can also register to receive notifications automatically when the offender is released, transferred, flees, dies or has a change in parole or probation status.
