STEP 2 RATES

APPLICABILITY

Applicable within the entire territory served.

AVAILABILITY

Available for general domestic, commercial and industrial service (except for unusual industrial waste) and sale for resale water service.

(I) RATES *

First	5,000 gallons used per month	\$21.29 per 1,000 gallons
Next	5,000 gallons used per month	\$20.70 per 1,000 gallons
Next	10,000 gallons used per month	\$19.76 per 1,000 gallons
All Over	20,000 gallons used per month	\$18.77 per 1,000 gallons

(I) MINIMUM CHARGE *

No bill will be rendered for less than the following amounts, according to the size of the meter installed:

5/8 inch meter	\$ 63.88 per month
3/4 inch meter	\$ 95.82 per month
1 inch meter	\$159.70 per month
1-1/2 inch meter	\$319.40 per month
2 inch meter	\$511.04 per month

RESALE RATE *

\$4.90 per 1,000 gallons

DELAYED PAYMENT PENALTY *

The above schedule is net. On all accounts not paid in full when due, ten percent will be added to the net current amount unpaid. This delayed payment penalty is not interest and is to be collected only once for each bill where it is appropriate.

RECONNECTION - \$20.00

To be charged whenever the supply of water is turned off for violations of rules, non-payment of bills, or fraudulent use of water.

STEP 2 RATES (Continued)

TAP FEE

The following charge is to be made whenever the utility installs a new tap to serve an applicant.

A tap fee of \$300.00 will be charged to all customers who apply for service outside of a certificate proceeding before the Commission for each new tap to the system.

LEAK ADJUSTMENT *

\$4.41 per 1,000 gallons is to be used when the bill reflects unusual consumption which can be attributed to eligible water leakage on the customer's side of the meter. This rate shall be applied to all such consumption above 200% of the customer's historical average usage.

RETURNED CHECK CHARGE

A service charge equal to the actual bank fee assessed to the District up to a maximum of \$25.00 will be imposed upon any customer whose check for payment of charges is returned by the bank due to insufficient funds.

SECURITY DEPOSIT

Not to exceed two times the average monthly bill of the applicant's specific customer class, or fifty dollars, whichever is greater. This fee may be changed by applicable statutory provisions.

(D) * 6.66% CASH WORKING CAPITAL RESERVE INCREMENT

6.66% of total billings at the indicated rates is required to be recorded as a credit to "Miscellaneous Operating Reserves," with related collections to be charged to "Other Special Funds" and deposited into a distinct CWCR Bank Account.
