We deny the protest. BACKGROUND On May 8, 2015, DLA published a notice on the Federal Business Opportunity (FedBizOpps) website[1], stating that it was considering issuing a contract and granting a long-term, indefinite supply purchase order (IDPO) for various types of battle knives, including one with state stock numbers (NSN) 1095-01-466-8569. In its notification, DLA asked potential suppliers to respond to the survey by 14 May and, inter alia, to indicate the company's small business and socioeconomic status and whether it is a producer or reseller of the product. Id. DLA did not receive any responses by 14 May; however, at one point it received responses from Gerber, ARG Tactical, and Benchmade Knife Company expressing interest in the long-term contract. SPE7MX-15-X-0016 through a full and open tender in search of bids for a five-year, IDPO contract for battle knives with NSN 1095-01-466-8569. The protest at 4-5[2] on 10 September arg tactical, a reseller of knife SDVOSB, emailed DLA and challenged the agency's decision to issue the contract through a full and open tender because it had won previous contracts on this issue based on its SDVOSB status. Protest 5 [3] On 26 October, the DLA confirmed the previous purchase history and has received interest only from the following three vendors: Benchmade Knife (small business manufacturer), Gerber (a large business manufacturer) and ARG Tactical (SDVOSB reseller benchmade Knife). AR, Table 2, Purchase order; Table 13, Award Notice, p. 1. On February 9, Gerber wrote to DLA and outlined the reasons it believed arg tactical s or not qualify as SDVOSB. AR, Tab 10, Gerber letter to DLA. [4] On 12 February, Gerber lodged a protest with the office. DISCUSSION Gerber challenges the agency's SDVOSB sole source of the prize for battle knives. In particular, the protester claims that the agency is prohibited from awarding the SDVOSB's sole source code prize if it can meet the requirement through the FSS. Protest 1. Therefore, we usually reject a protest Rules, 4 CFR § 21.5 (b)(1).
