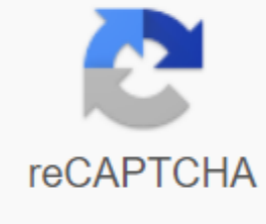

Kankaki County is bordered by the following counties: Will County to the north; Lake County, Indiana, Northeast; Newton County, Indiana, in the east; Iroquois County in the south; Ford County in the Southwest; Livingston County in the Southwest; and Grundy County in the northwest. These records can be obtained by checking online profiles. To do a public record search online, you will need to visit the Kankakee County Clerk's website. The website has easy to follow the steps and links that directly get you the entries that are available. Another way to access copies of records is by visiting the clerk's office in person. You will need to submit a completed entry request form, a form available at the clerk's office or downloaded from the county's website.
