Safety Protocols during COVID-19 Pandemic (FOR IN-STUDIO CLASSES)

Parents must read and agree to the Liability Waiver (next page) before allowing a dancer to attend an in person class or before booking a private. The waiver signifies your release of liability against any injuries or illnesses that may arise from being at B. Funk Dance Company. The waiver also certifies that your dancer is healthy, symptom free, and temperature free, and has not been in contact with anyone that has tested positive for COVID-19 within the 14 days immediately preceding attendance at any in-studio dance class. You must inform B. Funk staff if your child becomes ill with COVID-19 while enrolled in dance classes.

Parents are responsible for ensuring their dancer arrives a few minutes before class (or private lesson) and that they are wearing a mask, dressed in proper attire for class. Parents are **not** permitted to come into or wait in the studio or private lesson. Your dancer will be met at the door by a faculty or staff member and will be directed to wait outside with their class. Temperatures will be taken of everyone and then dancers will be ushered into the studio to their classroom. Dancers will be ushered back to the front door at the end of class. If anyone's temperature is above 99.5 degrees, they will not be allowed to enter the studio.

Dancers may bring bottled water or a beverage and cell phone; no other persons, clothing or personal items are permitted. Exception: If dancers are taking more than one class that requires different attire, then a small bag may be brought with the additional items. Dancers are not permitted to go into other parts of the studio except to use the bathroom or to use the changing room to change. Dancers are not permitted to wait in the lobby or any other part of the studio.

Teachers will wear masks and will maintain a 6 foot distance from the dancer at all times. Teachers will not touch dancers for corrections. Teachers must follow the safety protocols described herein and also must sign a liability waiver with the studio.

Class sizes are limited to 8-16 dancers per class based on each studio room size (or 25-30 dancers for Studios A and B combined) to ensure social distancing guidelines are met. Six foot by six foot squares have been taped onto the floor of each studio so the appropriate distance can be easily maintained.

Liability Waiver during COVID-19 Pandemic (FOR IN-STUDIO CLASSES)

I hereby waive and release B. Funk Dance Company, its staff, and independent contractors from any and all liability for any injuries or illnesses incurred while at B. Funk Dance Company.

I certify that my dancer is symptom-free as it relates to the coronavirus and has not been in contact with anyone that has tested positive for the coronavirus within the 14 days immediately preceding attendance at any in-studio dance class. Furthermore, I agree to inform B. Funk staff if my child becomes ill with COVID-19 while enrolled.

I agree to drop off my dancer dressed and on time and that she or he will **only** have a bottled beverage and phone. I understand that I am not allowed to enter the studio and that a faculty member will meet my dancer at the door and usher my dancer to the front door at the end of class.

I certify that I have reviewed and explained the safety protocols (see page 1) to my dancer and that she or he will remain with their class and not go into other parts of the studio other than to use the restroom or to change.

This waiver remains in effect for all time spent at the studio during the COVID-19 pandemic.
