INDIANA: HB1282 Protection at Conception Act

and regulating abortion and protected all
human life from conception. DIED IN
COMMITTEE.

Any pro-life regulation that allows even ONE baby to be killed is unjust and evil! Pro-life laws do NOT "chip away" at abortion, but legitimize it as health care. They pay reverence to and legitimize evil court rulings. They do virtually nothing to even curb abortion. Abortion is the ONLY act of murder that lawmakers seek to regulate rather than to outlaw. KILLING ANOTHER HUMAN BEING CANNOT BE MADE A "RIGHT." All "pro-life" incremental regulations specifically *permit* the murder of some babies under some circumstances. One cannot fight evil with evil!

"THE HEARTBEAT PROTECTION ACT" sacrifices every baby under 4 weeks & has exceptions up to 15 weeks for rape, incest & trafficking! Up to 24 weeks for a disabled child!
