

## UN Children's Day Art Competition 2021

The contest, running under the theme of “**Reimagining The Future After COVID-19**” calls for entries from **children and youths ages 6 to 18** to present unique perspectives and solutions to achieve the **Sustainable Development Goals (SDGs)**.

### Who Is Eligible?

- Open to children and youths (Category 1: aged 6-11, Category 2: aged 12-18) in Brunei.
- The contest aims to find **artwork (drawings, paintings or illustrations)** done by a child or youth living in Brunei that reimagines a green and more sustainable future after COVID-19 and what the Sustainable Development Goals (SDGs) mean to them.

- The deadline for submissions will be **11.59pm, 11 December 2021**.
- The winner of the contest will have their artwork posted on Instagram @MYactionsforsdgs and receive prizes.

### How To Submit?

- Scans or photographs of the artwork must be submitted in high resolution format (**e.g. PNG / JPG**).
- The artwork will be posted on myactionsforsdgs Instagram. We recommend a size that fits within the **1:1 ratio (square) of an Instagram post e.g. 21 × 21cm (1080 x 1080 px) or 21 x 29.7 cm (A4)**
- Artwork must be submitted to [actforsdgs.bn@gmail.com](mailto:actforsdgs.bn@gmail.com) along with the **full name and age of the child**.
- **A parent/guardian/school** must submit the artwork on behalf of the child entrant with full permission of the entrant, including their consent to the terms and conditions below. Schools must also have obtained the consent of that child's parent or guardian
- A participant is allowed to enter **one piece of artwork**.
- Please use the judging criteria below for guidance.
- The closing date for entries is **11.59pm, 11 December 2021**.

### Important Terms and Conditions

By submitting a piece of artwork, the entrant is deemed to have understood and accepted the following terms and conditions:

- All artwork submitted must be the original idea and creation of the entrant and must not infringe anyone else's rights.
- The artwork must not contain any personal information.
- It is the entrant's responsibility to ensure that any person who appears in their artwork has given appropriate permissions for their image to be used in accordance with these terms.
- By submitting artwork, all entrants (including the winning entrant and runners-up) provide their consent for their artwork to be used, free of charge, for other activity associated with MY Actions For SDGs, which includes being published online, social media activity and for display.
- By submitting artwork, entrants and persons submitting on their behalf agree that MY Actions For SDGs will use their personal information for administering this competition, press and advertising purposes, including publication (online or in printed form) of first name, age and broad location of the entrant alongside their artwork.
- Entrants agree to the cropping or other minor alterations to their artwork when used in accordance with these terms.

## Judging Criteria and Selection Panel

The theme of the competition is **“Reimagining The Future After COVID-19”**. The artwork must relate to the SDGs and issues relating to the SDGs such as sustainability, climate action, good health and well-being and quality education.

The artwork will be judged based on the following criteria:

- Impact of the artwork on the observer.
- Interpretation of the theme and its relevance to SDGs.
- Creativity and originality of the artwork
- Quality of overall design and style of artwork

The selection panel will include:

- Members of MY Actions For SDGs
- Event Partners
